Hi my name is Carolyn Forehand, and I met Chaplain David in 2013. My son Calvin Douglas met Chaplain David, while incarcerated in the Gwinnett County Jail. He connected with us, not knowing what he had unleashed. God used my son being in Gwinnett County Jail to connect me with Chaplain David. Neither my son nor I knew what God had brought forward! Little did I know my life was about to change for the better in the Spirit. God was taking me to another level; a level that I did not expect.

Before I met Chaplain David, I was sick. I had been attacked in a satanic way -- I lost everything and didn't have any money or anywhere to live with my two grandkids! But Abba Father had a plan, he connected me with a man that does not back down, a man who doesn't look at the negative but sees the positive. I used to say to myself who is this man and why is he concerned about me and my family.

Then one day God revealed to me that he was a Samuel in my life to direct me in the right path to be who He has called me to be. ### REAL RESULTS

Amazing results in the court halls of Clayton County Courthouse on 8/11/16: there were 26 people who received the message, and five who received Christ as their personal Savior.

One particular young man, Tyrell, had no knowledge of Christ at all, he didn't know what to believe or who to believe! The Holy Spirit gave me a strategy that had to be released to get his attention. And once the Holy Spirit revealed some things of his past that no one knew about, I saw a light turn on. It was a done deal, at that point God had His way with Tyrell. The Scripture that the Holy Spirit used, Jeremiah 29:11. "I know the plans I have for you... for a future and a hope." It was a much needed Word of hope for Tyrell, regardless of what happened in his past or what was happening now with the courts. Abba Father already knows what the end result will be. He revealed to him that he must stand still and see the salvation of the Lord!

There was another young man, Ben Bank. I was standing by the probation department office.

There were about 17 people. The Holy Spirit caught their attention as we joined in prayer!

Knowing that before we even go into His presence we must see that He can do anything, and believe that He can do the impossible.

He can remove any mountain. We must have faith that it's already done before we ask.

Most of these people were believers. This particular young man, though, gave so much attention and his spirit was wide open to receive what was said. Once the Holy Spirit was finished with that group I walked off and found another group of people, yet I kept watching this young man and I wanted to pray for him. But at that time there was a young lady and she was in desperate need of prayer.

When I finished praying for her, I looked over to pray with him, but he had already gone to the probation office. But later, when I left the building, I saw him and he told me that his probation officer released him off of probation. He couldn't figure out why she did it.

Then he said, "I gotta find that little lady, whom God use to speak to me and tell her what happened." This young man was literally shaking he was so surprised. He was so happy that God showed up that moment and they gave him his Walking Papers, when it should have been a violation. God worked and he was exonerated, and relieved. To God be the glory.
