EXPUNGEMENT ERASER !

DID YOU KNOW Georgia has the highest rate of correctional control in the country, yet is has one of the most restrictive expungement laws. At least 40 states allow expungement of some convictions, but currently in Georgia, only arrests that did not lead to a conviction and certain misdemeanor convictions before someone turned 21 can be expunged. Everything else stays on your record forever in GA. That is lifetime barriers, even after a person’s sentence is over – Basically the collateral consequences.

Current incarcerated in GA – 90,000
Current under correctional control in GA – 435,000
Current total with a criminal record in GA - 4.2 million

Second Chance for Georgia Campaign

aims to change Georgia’s expungement law to allow expungement of certain misdemeanor an felony convictions after a period of conviction-free years. A conviction shouldn’t be a life sentence to poverty and unemployment.

State of Georgia has erased “the BOX” on employment applications, but it is the decision of any company to follow this example. The mindset is **“Our resume does not control our future”.**

If God can take a risk hiring Moses, a murderer, to bring deliverance to 3 million Israelites from slavery or trust selecting Saul, a terrorist, to carry His Gospel and plant churches to all of Europe, **He can pick anyone to get his work done. He is a God of a second chance.**




NEAR SIGHTED
