Before our prayer walk around the Judicial Center, Russell Graves had pre-arranged a meeting with **Judge Ken Wynne (white shirt)** in the center. His warm reception to ministering to families at their weakest moments in the court halls



was welcomed and unprecedented. **We covet your prayers that God's extended favor in Newton Co. will be a launching pad for all Atlanta.**

Josh Mossman (blue shirt) from Covington in Newton Co. housing projects has had an extreme difficult family upbringing. Through our connections at the Gwinnett court halls, we connected! His vision now. *"I have been praying earnestly for wisdom and understanding. I was answered in a dream.*

In this dream God told me to gather my people. Now I have understanding and purpose: We must move with purpose. We must unite judges police officers in communities. We must bring together our communities and all Representatives of the State. Our country was founded under God and under God it will stand. I would like to have a very special event for judges of the Gwinnett and Newton County to come together including police departments to meet each other and to pray as one. we all need to be a part of a community. The **Bud and Miron McGraw** family have been a blessing to FBC Lilburn since the 60's. But even more so under the leadership of Miron McGraw quilting together blankets through donated fabricates.

It's beginnings was in the heart of women through Women On Mission. It was born in their hearts to do something tangible with the Gospel for the homeless, and struggling families. Historical records are unclear, but their heritage of sewing **250 blankets each year** is an amazing accomplishment. They have been delivered to many poor homeless in metro Atlanta, other countries, and to the elderly in the nation of Israel.

But Miron's many years of investment into untold thousands of blankets has significantly declined with her own age and health issues. That brings them to a reality of a fading blanket ministry after all these decades.

In absence of Miron's health, **Kate Fredrick** (pictured above in the center) has taken the lead. But likewise several of the sewers have passed on or dropping out with various health issues.

Except the younger generation of sewers chime in to carry on this beautiful homemade Gospel quilt, it will cease to exist. That was not Miron's intention at all in some of her last remembered words she could speak.

Miraculously a vision for a generational bridge is piecing together for the younger generation through our Chaplain Oscar Lopez (above red shirt). Oscar and I have networked together for years.
