OUR STORY OF CLOSED DOORS

TO OUR STONE MOUNTAIN REVIVAL ...

...is still stunning to me in the parallel experiences God accomplished on top of mountains in the Bible. My call into the ministry training from 1977-79 at New Orleans Baptist Theological Seminary was no doubt an exciting yet long uncharted desert road with a many unexpected turns.

Working nights at Roadway, taking daytime classes, and family growing responsibilities to get my Master's of Religious Education degree was an uphill road. It was the beginning of rocky trails, and major setbacks, and detours, We were left in a fog not understanding God's closed doors when we both were giving our best. Finally, having to give up our mobile home in Louisiana, we had to come back to Georgia our home.

Even 1984-2003 I went back to the secular employment with our three children. No matter which ministry door I tried to go through nothing open up. <u>The only door open</u> was volunteering in the Diversion and Detention Center for almost 20 years in Gwinnett County. I witnessed hundreds of inmate successful responses.

But I often wandered in my heart how would I keep up strong relationships after they were released or where they were going. Who was going to "bridge the gap" between released prisoners and the church? In 2003, the impression on my heart was so strong from God that He told me to leave everything and go full time as a chaplain.

At 52 years old, after being approved and endorsed by North American Mission Board with the Southern Baptist Convention as a Chaplain, I registered Bridge The Gap Ministries, Inc. as a nonprofit 501c1 status through a close friend's compassionate help.

Then we began to realize that closed doors was God's direction we could not see. Not knowing where to start, I climbed to the top of Stone Mountain in GA to wait and listen all day to God. His revelation of helping inmates after they are released lead to the beginning where all charges start at the courthouse.

After circling the courthouse in prayer for several weeks, God impressed me to go on the inside where I had never been before. What I saw was amazing - people on the first floor go in and out of court rooms. This was my first experience of the court system my whole life, and my visible depiction of what God has been doing for thousands of years in His world.

God's courthouse (Tabernacle) with Moses in the desert was the center of their camp. This same court system has expanded worldwide in every city. It now explains the full purpose of earth and why it exists in the first place. Every human being is waiting on God's court hall (earth) preparing to go to court with God our Judge, and Jesus our Attorney.

Since the beginning of BTGM 2003, we have witnessed thousands of miracles in people's lives praying with them before entering the courtroom. Even praying with couples before their commitment in marriage before God. Shocked faces that anyone would take the time to pray with them before they go to court. From the center of the county courthouse the entire county can be reached with the Gospel.

We pray weekly in the auditorium for all our 45 judges, commissioners, District Attorney, security guards, US representative, probate courts, and revival.

Jeremiah 29:11 is famously quoted as a restoration promise to Judah after 70 years in exile "work release" for the Babylonians. God assured they will return to their homeland in Israel. Greater Gwinnett Reentry Alliance into our 7th year is witnessing the same regeneration, and transformation to mobilization of changed hearts in returning citizens. (Average nationwide recidivism rate - 40%) Our annual 2022 Symposium has expanded to where even "returning citizens" have begun their own ministries. Several ministries were displayed in the dining at First Baptist

Church of Snellville. The Greater Gwinnett Reentry Alliance was formed to serve as a <u>reentry bridge of success back into society</u>. There are many complexities facing returning citizens. Transportation, housing, job acceptance, and acceptance in a church home to replace their old acquaintance. These practical primary roles promote and educate them when facing these obstacles to become stepping stones not stumbling blocks. So many returning citizens are needing a second chance of acceptance to become financially, emotionally, and spiritually mature and faithful in life.
